Right to erasure of data

Haarstudio Carine will erase your data without unreasonable delay. Fill in the reason(s) that apply:

Right to obtain restriction of processing

You want to obtain from Haarstudio Carine restriction of processing of personal data and one of the following applies:

- You contest the accuracy of the personal data. During the verification of the accuracy, Haarstudio Carine will not process your personal data.
- The processing is unlawful and you do not want Haarstudio Carine to erase the personal data but request the restriction of their use instead.
- Haarstudio Carine no longer needs the personal data for the purposes of the processing, but you require them for the establishment, exercise or defence of legal claims.
- You have objected against the processing, pending the verification whether the legitimate grounds of Haarstudio Carine override yours.

Right to data portability

- You want to receive the personal data provided to Haarstudio Carine in a structured, commonly used and digital format.

Right to object

You have the right to object, on grounds relating to your particular situation, to the processing of your personal data if they are processed on legitimate grounds, in the exercise of official authority or in the public interest.

Haarstudio Carine will only cease the processing of your personal data if it cannot demonstrate compelling legitimate grounds for the processing which override your interests, rights and freedoms or if those grounds are related to the establishment, exercise or defence of legal claims.

State the reason(s) for your objection:

- You want to object against the processing of your personal data for direct marketing purposes (which includes profiling to the extent that it is related to such direct marketing). Choose one of the options below:
 - You want Haarstudio Carine to erase all your data from its files. If Haarstudio Carine receives your data again from a third party, Haarstudio Carine is allowed to contact you again.
 - You want Haarstudio Carine to erase your personal data from its files and ensures that you will never receive direct marketing from Haarstudio Carine or a third partner.

2. Haarstudio Carine's response to your request

After receipt of this form, Haarstudio Carine will process the request. The response will be given in writing if a request was submitted by letter, and electronically if the request was submitted by email. Haarstudio Carine will provide you with information on the action taken on your request as soon as possible, however in any case within one month if receipt of the request. Taking into account the complexity of your request and the number of requests, that period may be extended by two further months where necessary. In that case, Haarstudio Carine will inform you within one month of receipt of your request.

If Haarstudio Carine does not take action on your request, Haarstudio Carine will inform you within one month of receipt of your request, stating the reasons for not taking action. Haarstudio Carine will also inform you about the possibility of (i) lodging a complaint to a supervisory authority or (ii) seeking a judicial remedy.

3. Proof of your identity

As proof of your identity, you must attach a copy of your ID card to this form. Make a protected copy and cover your citizen service number (Burgerservicenummer - BSN). Or use the KopieID app to make a copy.

If, however, Haarstudio Carine has reasons to doubt your identity, it is entitled to ask you for additional information to confirm your identity.
